❑ **IRS UPDATE**

Prior to a September 30th submission to the IRS there were 58 ASGs under UOAA's 501(c)(3) Charity Status. 29 more ASGs were included in our September 30th submission. We anticipate that the IRS will approve these additions by early 2010. Our next filing with the IRS will be in March 2010. Those ASGs who aren't already under UOAA's umbrella, and do not have their own 501(c)(3) status, are encouraged to come under at this time (not applicable to hospital-based ASGs). It is as simple as writing a letter to the UOAA Office requesting that your group be included in the March 2010 submission.

Remember that ASGs cannot continue to use UOAA's 501(c)(3) since UOAA no longer exists.

The Annual Affiliation Fee for 2010 will be mailed from the Office on December 1st. The rate will remain \$ 2.00/member or a flat rate of \$ 25 for those small and hospital based groups whose members do not pay dues. Also, election ballots need to be returned to the Office no later than November 30th.

□ OSTOMY PATIENT SKILLS KIT

Under the direction of the American College of Surgeons 10,000 "Ostomy Patient Skills Kits" will be produced for distribution by Colorectal Surgeons to their

patients before they undergo ostomy surgery. The kits are designed to provide information about stoma management appliances and techniques. UOAA was part of the Taskforce asked to review the kit's contents and endorse program. Our MBoD gave the requested endorsement. At UOAA's request an information card providing contact information for UOAA and its ASGs will be included in the kit.
